What data do we collect?

Our Company collects the following data:

- Personal identification information (Name, email address, phone number)
- Depending on the purpose you visit our website, in addition to the above, we may collect company name, private or business address, zip, city, country, company registration number and/or VAT number and, related to the career page on our website, we collect date of birth.

How do we collect your data?

You directly provide Our Company with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Apply related to a published vacancy on our website
- Use or view our website via your browser's cookies.

How will we use your data?

Our Company collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.
- Process the job application you have submitted.

Unless you state otherwise, we will share your data with our Group companies listed in the heading so that they may offer you their products and services and/or review your job application.

When Our Company processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Our Company securely stores your personal and professional data at our own servers which are GDPR compliant maintained and reviewed.

Our Company will keep your personal data related to job applications for a 3 year period. Once this time period has expired, we will delete your data by eliminating your records from both the servers as well as from the back up files.

Marketing

Our Company would like to send you information about products and services of ours that we think you might like, as well as those of our Group companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Our Company from contacting you for marketing purposes or giving your data to other members of the Our Company Group.

What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Our Company erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.

How do we use cookies?
